Sealed proposals, endorsed with the corresponding proposal description “ **Quotation No: SCM 11/2018 Review of 2018/19 IDP**” must be placed in the Bid Box at the office of Hantam Municipality, 20 HOOP STREET, CALVINIA, 8190. Postal delivery must reach Hantam Municipality, Private Bag X 14, CALVINIA, 8190, not later than **12:00 on Wednesday 31 January 2018**, after which the bids will be opened in public.

Quotations must reach this office no later than **Wednesday, 31 January 2018** at 12:00  
Suppliers should **PLEASE** beware of the following aspects:

- **Bids which are deposited late, incomplete, unsigned, or submitted per facsimile or electronically will not be considered. No reason for the rejection of a bid shall be provided and the client shall not enter into any correspondence regarding this.**
- **All bids will be adjudicated and awarded in terms of the Hantam Supply Chain Management Policy, the Preferential Policy Framework Act 2000 (Act No. 5 of 2000) and the regulations promulgated under this Act, value for money and, capability to execute the contract and the relevant specifications for the drafting of a credible IDP.**
- **The Municipality does not bind itself to accept the lowest or any bid and reserves the right to accept the whole or only part of a bid if (a) the bid amounts**

- received are too high; (b) the bids do not comply with the specific bid goals; or (c) objective criteria exist which justify or necessitate the non-acceptance of any bids
- **Your CSD (MAAAO) Registration Number must be included in your application.**
  - **Valid SARS Certificate of your business must be attached.**
  - **Bidders must submit a certificate certifying that the bidder has no undisputed commitments for municipal services towards a municipality or service provider i.r.o. payments which is overdue more than 30 days.**
  - **Municipal services account must be included in your quote.**
  - **The bid will be adjudicated on the following criteria: Price = 80 points. BBEE contribution level = 20 points.**
  - **No potential provider of which a government official, either Director, Partner and/ or Management may apply. (SCM Regulation 45)**
  - **MBD4, MBD 8 en MBD9 must be completed.**
  - **Prizes will be considered according to the prescribed Supply Chain Management Regulations, and the the 80/20 scoring system as prescribed in the PFFFA, 5 of 2000.**
